

Nishicon 2023 Dealer information.

This document contains information for exhibitors for Nishicon 2023. If you have any questions or comments regarding this, you can always contact us at dealers@nishicon.nl or for general questions via info@nishicon.nl

Also during Nishicon2023 you can always speak to a staff member or a gopher if there is anything. During the opening hours of the dealer room, the Dealer Room Staff member or otherwise an acting gopher is present in the dealer room.

In addition to this information document you can also find our **subscribe document** and the **online registration form**. Through filling in 1 of these 2 forms you can sign up for Nishicon 2023. We prefer the use of the online form. After registration you will receive a confirmation by e-mail, which will also have the dealer contract and the invoice for the costs of the stand and tickets. You will also find our prices in the registration form.

The dealer contract must be read and completed in full and returned to us.

The house rules for the dealers also apply. These can be found on our website, <u>www.nishicon.nl</u>, under 'house rules'.

We hope for a smooth cooperation and a pleasant and successful weekend during Nishicon 2023.



Opening and closing times.

Nishicon 2023 will be held on Sunday 12 November 2023.

!Note that this means that Nishicon is a one-day edition. Next year Nishicon will be two days again!

The opening hours of the dealer room are: 11:00 - 19:00. It is possible for dealers to unload on Saturday evening and also to build up.

From Saturday 8:30 AM, dealers get to the location to set up their booths. Breaking down is done from 19:00. The dealer room must be left completely empty again.

Cost - professional seller or hobby/craft.

Dealers can sign up as a professional seller or as a hobby/craft. A lower rate applies to hobby/craft, but they also have a maximum number of tables of 3.

All prices are stated in the registration form. Dealers can order a number of meters of tables and/or free space as desired, and one or more dealer tickets. The ticket prices, just like the regular visitor tickets, depend on the date that is ordered.

Location and layout.

!Please note, the dealer room is located on the 3rd floor. There is a regular elevator that goes directly to this from the main entrance. This does mean that it can be busy with the use of the lift during construction and dismantling.

The dealer room map will be sent to all dealers before the start of Nishicon.

Next to the location there is space for cars, vans and trucks to load and unload. The vehicles can then be parked in one of the parking garages. If necessary, make sure that the parking garage is suitable for the height of the vehicle.

The tables are 120 x 75 cm.

Consumptions.

The location of Nishicon 2023, Dynamo, has its own catering for drinks. The location has no facilities for food. There will be a food court. The location does not allow your own drinks, but bringing your own food is no problem for the location.

Dynamo is located in the center of Eindhoven. This means it is easy to find food and drink outside the venue.



Bootleg, AI art, and goodie bags.

It is strictly forbidden for dealers to sell bootleg merchandise. We as an organization attach great importance to this. Bootleg refers to goods that have been manufactured without an official license from the rightful owner and that are copies of original products, such as DVDs, clothing, figures and other articles. These are often much cheaper and are often of inferior quality compared to the official goods. Each product must have a copyright text, which includes the name of the copyright holder. As an organization we will therefore be vigilant about this and check the goods offered for sale at every stand.

Crafts and artists should only sell their self made products. Products made through AI software are not self made, unless the dealer can prove the AI software has been trained only with self made artworks.

If bootleg products are found at a dealer, they will be asked once to remove all bootleg products. In case of refusal or a second time, the dealer contract will be dissolved and the dealer will be asked to leave the premises. There will be no refund of the stand and ticket costs.

Because it is impossible for our crew to check goodie bags for bootlegs, they will not be allowed at all!

Deposit and clean up.

To ensure that the dealer room is clean and empty on Sunday after the event, all dealers pay a deposit of \in 5 per table, with a maximum of \in 25.. This deposit will be refunded if your booth location is left clean. If there is still waste or goods at the stand after 20:00, the location, Dynamo, will charge costs for this. These will be paid by us through the deposit.

The location has trolleys, but these may not be enough for all exhibitors. If necessary, it is wise to bring your own, to ensure that everything can be put away in time on Sunday evening.



Refusals and reserve list.

Stichtin Nishi reserves the right to refuse registrations from exhibitors on one or more of the following grounds:

- The exhibitor has broken rules at a previous Nishicon event.
- Because of the diversity of exhibitors. To ensure a good distribution between, for example, artists, figure sellers, manga sellers, clothing sellers, and other sellers.
- The exhibitor only or mainly sells products that do not fall within the target group of the convention.
- The dealer room is full.

In addition to being refused, exhibitors can also be placed on the reserve list. In the event of cancellation, an exhibitor can still be offered a place in the dealer room at a later stage.

Change and cancel.

From 1 month before the convention, October 12, 2023, cancellation or reduction of the number of tables/tickets is no longer possible, subject to exceptions. From 2 weeks before the convention, October 29, 2023, we can no longer guarantee that additional tables can be ordered.
